- I. In the reference 1st cited, an application was submitted to the Board seeking Consent for Establishment (CFE) to set up Common Bio-Medical Waste Treatment and Disposal Facility (CBMTDF) with installed capacities of Incinerator- 100 kgs/hr. The total cost is Rs.39.88 lakhs and will be situated in an area of 6.15 acres land.
- II. As per the application, the treatment facility is to be located at Sy. No. 179, Edulagattepally (V), Manadondur (M), Karimnagar District.
- III. The above site was inspected by the Regional Officer, A.P. Pollution Control Board, Ramagundam on 02.07.2005.
- IV. The Board, after careful scrutiny of the application and verification report of Regional Officer, hereby issues **CONSENT FOR ESTABLISHMENT** to your facility Under Section 25 of Water (Prevention & Control of Pollution) Act 1974 and under Section 21 of Air (Prevention & Control of Pollution) Act, 1981 and the rules made there under. This order is issued for establishment of the Common Bio-Medical Waste Treatment Facility mentioned at para (I) only.
- V. This order is issued from pollution control point of view only. Zoning and other regulations are not considered.
- VI. This Consent Order now issued is subject to the conditions mentioned in Schedule 'A' and Schedule 'B'.

- VII. The proponent shall immediately submit the detailed time schedule for the completion of the works and commissioning of the plant. The time schedule shall reach this office within one month from the date of issue of the order. However, the time schedule shall not exceed nine months from the date of issue of the Consent Order, failing which the Consent Order shall be cancelled without further notice.
